



Official Rules

Forrit Credit Union Back-to-School Giveaway

Effective August 1 through August 26, 2024.

NO PURCHASE, LOAN, OR REQUEST FOR INFORMATION REQUIRED TO ENTER TO WIN. A PURCHASE, ACCOUNT, LOAN OR REQUEST FOR INFORMATION WILL NOT INCREASE YOUR CHANCES OF WINNING.

These Official Contest Rules apply to the Forrit Credit Union Back-to-School Giveaway ("Giveaway") to be held from August 1, 2024, to August 26, 2024. The winners will be notified August 27th, 2024. All prize winners will be selected at random based on colored or completed activity worksheet ("Worksheet") submitted to the Contest as described in the Selection of Winners, below.

By participating in the Contest, the Participant agrees to these official rules. Results of the Contest are final in all respects. Void where prohibited by law.

CONTEST PERIOD: The contest begins on August 1, 2024 and ends on August 26, 2024 (the "Giveaway Period"). Entries must be received during the Giveaway Period.

PRIZE: Forrit Credit Union ("Credit Union") will award a total of two prizes. The prize will be a \$50 Fred Meyer giftcard. Odds of winning any prize will depend on the actual number of eligible entries by the Credit Union prior to the deadline for entry described below. The Credit Union reserves the right to award additional winners and prizes. Payment of any and all federal, state and local taxes associated with each prize will be the responsibility of the parent or legal guardian of the winner of each prize.

WINNER SELECTION: Two winners will be randomly selected from among all qualified entries submitted during the Giveaway Period. Winner selection will be determined on August 27, 2024. Individuals need not be present to win. The odds of winning Prize depend on the total number of qualified entries. The Credit Union will notify the prizewinner personally by either phone, email, or Facebook/Instagram Message. It shall be the responsibility of entrants to provide contact information within their Facebook/Instagram Account to be eligible to collect the prize. Entrants may be asked to provide proof of eligibility to enter.

No transfer or substitution of prizes is permitted. All federal, state, and local taxes, if any, are the sole responsibility of the winner. Winner must claim the prize within seven (7) business days of being notified by the Credit Union or entrant will be deemed to have forfeited the prize. Should a prize be forfeited, an alternate winner will be chosen from the remaining eligible entrants in a separate random drawing conducted by the Credit Union.

ELIGIBILITY: The parent or legal guardian of any child between the ages of 0 -17 residing in the United States, may enter that child's Worksheet into the Giveaway. One entry per child. Officers, directors, volunteers and employees of the Credit Union, or its affiliates, advertising public relations, accounting or legal firms, and immediate family members or individuals living in the same household of such employees, are not eligible to win the Giveaway.

ADDITIONAL AGREEMENTS/WAIVERS: By entering a child's Worksheet into the Giveaway, the parent or legal guardian of the child agrees, on behalf of the child and on behalf of the parent or legal guardian, (a) to be bound by these Official Giveaway Rules and to interpretation of these rules by the Credit Union and (b) that the Credit Union and its respective affiliates, agents, representatives and employees will have no liability whatsoever for any injuries, losses or damages of any kind resulting from acceptance or use of the prize(s). Except as prohibited by law, the parent or legal guardian of each winner also consents on behalf of the child winning the Giveaway, by entering the Giveaway and without further compensation, to the Credit Union's use and publication of the winner's name, photograph, likeness, biographical information, Worksheet, and details of winning for Credit Union advertising, promotional, or regulatory purposes.
